#### **ELIGIBILITY REQUIREMENTS:**

- 1. Applicants must be a resident of B.C.
- 2. Applicants must be a regular or junior member of Holstein Canada; or a son/daughter of a member of Holstein Canada; or a son/daughter of a past member of Holstein Canada; or past/present member of a 4-H club with a dairy project.

#### **GUIDELINES:**

### POST SECONDARY BURSARY

- 1. Must have completed at least first year of University, college or Technical school (in any area of study) and must be continuing with studies.
- 2. Must attain high standing in course work an official transcript must be available on request.
- 3. Must submit a resume of significant 4-H achievements (if applicable); Certified by a 4-H Leader
- 4. Must submit an outline of a farm and/or industry involvement (if applicable).
- 5. Must provide a short essay on career goals (not necessarily in dairy industry).

APPLICATIONS TO BE RECEIVED BY OCTOBER 31'24. THE WINNERS WILL BE NOTIFIED. NO INDIVIDUAL WILL BE ELIGIBLE FOR THE SAME AWARD TWICE.
